2024 Annual Plan

Below is a plan for spending Capital Funds for our public housing program in 2024. We will not know until March of 2024 what the US Department of Housing and Urban Development (HUD) will provide us for funding, so our plan is based on low estimates. We expect that we will be able to increase our dollars for projects. Our main objective is to have all prioritized projects listed.

We use the projects for our Annual Plan from our 5-Year Plan. Due to 2024 being the final year of the plan, there are a lot of jobs included. This is due to the HUD Process. Year 5 has a lot of projects that are place holders and we anticipate quite a bit of change- mostly through elimination of non-prioritized projects. We may move projects from any year within the 5-year plan. Any project not included in the 5-Year Plan must go through a separate approval plan with HUD.
